Quotation for Sport Climbing and Allied Adventure Activities

1. Indian Mountaineering Foundation invites the quotation to utilize the services of suitably qualified resourceful persons for the conduct of Sport Climbing and Associated Adventure Activities on contract basis for one year in the IMF Complex. Vendors may send their proposals under two categories: one to use their own equipment during the contract period and second if the equipment is provided by the IMF. Quotations are invited in sealed envelope by hand/by post in this office by 12th May 2022 at 4.00 PM. Following minimum QRs are expected from the quotations:-

- (a) Complete profile of the Company.
- (b) The resource person must have sound knowledge of conducting Sport Climbing activities on Sport Climbing Wall (i.e. Qualified Belayers, Route Setters and Holds). The Bio-data of minimum 15 instructors should be sent alongwith quotation.
- (c) The service provider will provide suitably trained Instructors as per requirement of the IMF.
- (d) There will be two shifts per day of 4 hours duration each. Night climbing may be conducted as and when required with prior permission of IMF.
- (e) Instructors would be required to adhere to the IMF discipline, punctuality, norms and fully comply with the laid down timings and Code of Conduct. They will exhibit discipline of the highest order and should be properly dressed as per the requirement of the training
- (f) No regular instructor shall be absent from duty without permission of the IMF and if agreed to will provide a relief of suitable and qualified instructor to conduct training at the IMF.
- (g) Instructors should be fully qualified as per certificates/documents submitted to the IMF.
- (h) Instructors will be responsible for ensuring proper and efficient imparting of training. He will be responsible for complete safety of the trainees at all times.
- (i) Service Provider shall provide additional Instructors, whenever required.

(j) The Instructors will ensure proper maintenance of the Sport Climbing Wall and technical equipment being used for the training at the IMF Wall at all times. He will check the equipment being used for training before use.

(k) The cost of equipment if lost/damaged, deliberately/by negligence will be recovered from the service provider in case of Category-2 proposal when equipment is provided by the IMF.

(l) Instructors shall ensure that the surrounding areas around climbing walls are kept neat, clear and free of litter.

(m) Instructors will properly receive, utilize, maintain and retain the equipment being issued for training in case of Category-2 proposal when equipment is provided by the IMF.

(n) Monthly evaluation of equipment will be carried out. Reserve equipment for one month should always be available with the IMF in case of Category-2 proposal when equipment are provided by the IMF. In case of any discrepancy the issue will be brought to the notice of the Secretary and Director, IMF.

(o) Under no circumstance, the IMF equipment for wall climbing will be carried out side the IMF premises in case of Category-2 proposal when equipment are provided by the IMF.

(p) Instructors will be responsible for the discipline of the trainees during conduct of the training.

(q) Due to Covid-19 pandemic, all instructions and protocol will be followed as directed by the IMF from time to time.

2. We are inviting the quotation for the 02nd time as the first time quotation of all the vendors who applied for earlier quotation No. 01/IMF/SC/SP/2022 dated 18th April 2022 were cancelled because they were found incomplete and incorrect.

3. Please send the quotation with complete details, in case complete details are not received IMF has the option to reject the quotation.
