
QUOTATION FOR SPORT CLIMBING AND ALLIED ADVENTURE ACTIVITIES

1. Indian Mountaineering Foundation invites the quotation to utilize the services of suitably qualified resource persons for the conduct of Sport Climbing and Associated Adventure Activities utilizing existing facilities in as existing condition at IMF premises on contract basis for one year in the IMF Complex i.e from 01st June 2023 to 31st May 2024. Vendors may send their proposals under two categories i.e. category one to use their own equipment during the contract period and category two if the equipment is provided by the IMF. Quotations are invited in sealed envelope by hand/by post in this office by 13th June 2023 at 4.00 PM. Following minimum QRs are expected from the quotations:-

- (a) Complete profile of the Company.
- (b) The resource person must have sound knowledge of conducting Sport Climbing activities on Sport Climbing Wall (i.e. Qualified Belayers, Route Setters and Holds). The Bio-data of minimum 15 instructors should be sent alongwith quotation.
- (c) The service provider will provide suitably trained Instructors as per requirement of the IMF.
- (d) There will be two shifts per day of 4 hours duration each as per summer and winter timings as under:-
 - (i) October to March - 9.00 AM to 1.00 PM(Morning)
3.00PM to 7.00 PM(Evening)
 - (ii) April to September - 7.30 AM to 11.30 AM(Morning)
4.30 PM to 8.30 PM(Evening)
- (e) Night climbing may be conducted as and when required with prior permission of IMF only upto 10.00PM permitted.
- (f) Instructors would be required to adhere to the IMF discipline, punctuality, norms and fully comply with the laid down timings and Code of Conduct. They will exhibit discipline of the highest order and should be properly dressed as per the requirement of the training
- (g) No regular instructor shall be absent from duty without permission of the IMF and if agreed to will provide a relief of suitable and qualified instructor to conduct training at the IMF.
- (h) Instructors should be fully qualified as per certificates/documents submitted to the IMF.

- (i) Instructors will be responsible for ensuring proper and efficient imparting of training. He will be responsible for complete safety of the trainees at all times.
- (j) Service Provider shall provide additional Instructors, whenever required.
- (k) The Instructors will ensure proper maintenance of the Sport Climbing Wall and technical equipment being used for the training at the IMF Wall at all times. He will check the equipment being used for training before use.
- (l) The cost of equipment if lost/damaged deliberately/by negligence will be recovered from the service provider in case of Category-2 proposal when equipment is provided by the IMF.
- (m) Instructors shall ensure that the surrounding areas around climbing walls are kept neat, clear and free of litter.
- (n) Instructors will properly receive, utilize, maintain and retain the equipment being issued for training in case of Category-2 proposal when equipment is provided by the IMF.
- (o) Monthly evaluation of equipment will be carried out. Reserve equipment for one month should always be available with the IMF in case of Category-2 proposal when equipment are provided by the IMF. In case of any discrepancy the issue will be brought to the notice of the Secretary and Director, IMF.
- (p) Under no circumstance, the IMF equipment for wall climbing will be carried out side the IMF premises, in case of Category-2 proposal, when equipment are provided by the IMF.
- (q) Instructors will be responsible for the discipline of the trainees during conduct of the training.
- (r) Post to Covid-19 pandemic, all instructions and protocol will be followed as directed by the IMF from time to time.
